Board of Directors October 11, 2012

President Diana Zietz called the meeting to order.

Greg Larson gave the invocation, led the Pledge of Allegiance and REALTOR® Pledge.

Jeff Nelson, candidate for Region 8 Vice President for 2015, gave a presentation to the board via conference call.

A motion was made to move Item D, Legal Hotline Update, outside of the consent agenda for further discussion. (M/S/C)

The following items on the consent agenda were approved (M/S/C):

- Minutes from the September 13 meeting
- Local Board Reports
- Calendar of Upcoming Events
- Dakota CRS Chapter Report
- Convention Update

Ron Volk gave a report from the past RPAC Trustees meeting. The committee supported

the following candidates:

Insurance Commissioner: Adam Hamm

Governor: Jack Dalrymple Auditor: Bob Peterson

Public Service Commissioner: Randy Christmann

State Treasurer: Kelly Schmidt US House: Kevin Cramer US Senate: Rick Berg Diana Zietz gave the presidents report including: encouraging directors to attend the ND Housing Finance Agency's stakeholders meeting. A recommendation from the Executive Committee was made to put the Equal Opportunities committee under the Membership Committee. (M/S/C)

Rob Mehta, candidate for Region 8 Vice President for 2015, gave a presentation to the board via conference call.

A motion was made to support Jeff Nelson for Region 8 Vice President. (M/S/C)

At this point Scott Louser joined the meeting via conference call.

Scott Louser, VP Government Liason for NAR, gave an update via conference call, including RPAC concerns, how Congressman Rick Berg is doing in the election, polling the members about the transfer tax issue, and that he is going to be investigating running for NAR president.

President Diana finished the presidents report. She mentioned the following items:

- REALTOR® Ring Day is December 7th
- Buy a t-shirt for REALTOR® Spirit day in Orlando
- Remember to vote on November 6
- Upcoming education in Fargo on November 1 and 2 (CRS) and in Bismarck on December 5 and 6
- Legislative roundtables in Bismarck, Fargo Moorhead, and Grand Forks are set and others are in the works
- A Call to Action came out from NAR make sure to go out and respond
- We will be receiving the Presidents Cup in Orlando

Item D from the Consent Agenda, Legal Hotline Update, was added at this time. Casey Chapman gave an update on appraisal issues across the state.

Jill Beck gave the staff report. She reported on the following items:

- Legislative roundtables in Bismarck, Fargo Moorhead, and Grand Forks are set and others are in the works
- A Call to Action came out from NAR make sure to go out and respond
- Code of Ethics Quadrennial requirement deadline is December 31
- She is still attending meeting coalition meetings and keeping on top of issues arising
- She is participating on an Appraisal Coalition with independent banks, banks, and the Governor's office
- The transfer tax poll will be sent out soon. Local boards will be made aware when it goes out
- Financials (Jill touched on various line items)
 - The Edward Jones account was moved into Morgan Stanley \$251,000 in reserves
 - \$453,000 in checking and savings
 - Dues are ahead on budget
 - Management fees were transferred out
 - Working on finalizing the financials for the education courses
 - Income is on target
 - Committee budget is low but will increase
 - Region 8 Meeting still a work in progress with lowa to fix budget
 - Per accountants suggestion, temporary help expense is put into the Legal and Accounting item of that \$5,400 has been spent on legal and accountant and \$7,500 on temporary staff

Jill Beck went over the proposed 2013 budget. She pointed out the following differences from the 2012 budget to the 2013:

- REALTOR® membership numbers were increased by 50
- Decreased the number of affiliate membership by 10
- Others are staying the same
- Increased the political budget line from \$3,000 to \$8,000 due to the legislative year
- Committees are staying the same
- Marketing Funds the program was not budgeted for 2013
- Member Technology was decreased by \$1,500

- Travel will stay the same
- National Travel NAR budgets for \$1,000/FPC so that was decreased by \$3,000
- RVP line item will be lower because of the NAR director slot (since Daryl Braham will be serving as both NDAR NAR Director and RVP)
- Increased in-state president's budget up to \$500
- Travel Funds increased to \$15,000
- State Convention line item was increased
- Staffing budget was increased to hire another full-time position
- Set-aside was decreased by \$1,200
- Carry forward roughly \$2,900

The 2013 budget was approved. (M/S/C)

The 2012 goals were reviewed. They are on task.

Scott Breidenbach gave a Non-Dues Income report. The idea of the State Association and a local board going in together to purchase a commercial building was proposed. Boards to discuss if they would like to participate and bring back for further discussion.

The meeting was adjourned. (M/S/C)
