The meeting was called to order by Chair Lyn Dwyer and attendees were introduced.

Minutes from October 6, 2010 were reviewed and approved as presented. (M/S/C)

Reviewed member stats and demographics.

Local board reports were given regarding local events, speakers and activities.

The Marketing Co-op funding was discussed. The total budget for Membership committee is \$20,000.

A motion was made to continue with Marketing program and remove goal pertaining to tax credit (#2), add a goal to promote preserving the Mortgage Interest Deduction, and allow the Task Force to set a per-member reimbursement (M/S/C).

REALTOR Involvement Program – discussion held.

- Thank members for volunteering
- More promotion at local level
- Challenge to committee members to fill it out

Salvation Army – Debriefing is being scheduled with NDAR staff, local board volunteers, and Salvation army staff. Anyone with photos is asked to send them to NDAR for promotion. A motion was made to continue with the REALTOR® Ring Day program for 2011. (M/S/C) A motion was made to schedule the Salvation Army Ring Day on December 9. (M/S/C)

Our focus in 2011 is "It's All About YOU", the member. Our goals are to:

- improve communication to and from the Association to you
- develop innovative services and support in technology for you
- increase the efficiency of the business of the Association and for your business

Discussion regarding the Young Professionals Network (YPN) Chapter was held. "Next Realtor® Generation" (NRG) was suggested as a name change, which allows for new agents rather than defining by age. Staff will look into the possibility of changing the name.

Challenge to organize local groups to form the state chapter. Place on agenda for April meetings.

President Daryl addressed to group. Thanked Chair Lyn for "jumping in" as Chair without having served as Vice Chair because of changes.

Chris Polychron, 2015 NAR President spoke to the committee. He thanked everyone for their service and participation in the Association. He really feels the REALTOR® family here in ND.

NDAR Leadership has issued a challenge to all committees for 100% participation in RPAC. The focus is that ALL members of every committee give at least the \$30 per member goal. Leaders in the Association need to set the example and that will in turn help achieve the state goal of 75% participation overall. Larry Louser also mentioned his challenge to other states that ND will achieve 400% of the fair share goal as set by NAR.

Objectives from Board of Directors were reviewed and discussion was held for implementing them. In an effort to improve communication, it was suggested to look into new company for printing the quarterly newsletter. It was consensus that the content is good, but look for a company that can spruce up ads and the quality of printing. Get "bids" for same process as currently with BHG (Dave Lanpher & Dewey Uhlir will work with staff). Another idea was moving to an electronic newsletter instead of printed.

Weekly Podcast topic suggestions: Politics that affect our business, Link to Ron Phipps NAR President's Podcast, Mortgage Interest Deduction, Homeownership Matters, Legislative Update, Kick off for Salvation Army Ring day, House Logic, Affiliate members doing some, Well-spoken consumer – used Realton because...
