Again attendance was good and the reviews were favorable. GRI I and II were held in Fargo in the spring. Attendance was a little short, but believed to be at break-even status. ABR/SFR was also held this spring. The financials for these classes will be presented at the next meeting.

Upcoming classes were discussed.

Planning for 2013 Education – Many ideas were suggested. Some ideas were CRB, Cultural Diversity, Investment Properties (commercial and rental), Mineral Rights, Fair Housing, Construction, and a Carol Lawlun class.

Education Requirements Task Force Update – No report was given.
