- •Every ND licensee (except those that are exempt or licensed within the last year) will need 9 hours continuing education (CE) from January 1, 2015 through date to be determined by ND Real Estate Commission (see below) of which at least 3 hours must be taken in the Mandatory topic of Personal Safety.

Please Note: There is proposed legislation to change the license renewal date to an earlier date than December 31st. The ND RE Commission is considering November 15th as a renewal date, so please remember this when scheduling your CE. Should the bill pass the legislature, the Commission will need to make Administrative Rule changes to finalize the renewal date.

- •Note: Courses that meet the mandatory CE topic will have a course code starting with Man15.
- •KEEP YOUR CE CERTIFICATES: Each REALTOR® / Licensee is responsible for keeping CE Certificates. If you have lost certificates you will have to get a duplicate from the entity that sponsored the course you attended.
