ND Real Estate Commission Schedules Rules Hearing

A public hearing to receive comments on proposed rules changes is scheduled for 9:00 am CDT, Thursday, May 7, 2015 at the Leadership Hall Room 201, Bank of North Dakota, 1200 Memorial Highway, Bismarck, North Dakota. A meeting of the commission will follow.

The purpose of the proposed rules and amendments is to comply with changes in statute resulting from HB1074 enacted during the most recent legislative session relating to the application deadline for renewal of a real estate license and to update and clarify certain provisions pertaining to non-resident licensure, trust accounts, continuing education, and out of state commission splits. Changes for Applicant Licensure

Effective April 1, 2015, in accordance with the NDCC 12-60-24 and 43-23-08.4, any applicant for licensure with the North Dakota Real Estate Commission or a licensee whose licensure is subject to investigation by the Commission shall be subject to a statewide and nationwide criminal history record check. *Please note that this will add several weeks to the process so make sure applicants are getting their applications and kits returned in a timely manner. RESPA Marketing Webinar Re-Cap

On March 19, 2015 NAR hosted a <u>webinar</u> on marketing and services agreements (MSAs) and other agreements under the Real Estate Settlement Procedures Act (RESPA). There have been a number of enforcement actions targeting disclosures and practices under the anti-kickback provisions of RESPA. No one may give or accept anything of value for the referral of settlement services in residential transactions involving a mortgage. MSAs are under particular scrutiny.
