New Online REALTOR® Code of Ethics Course – with CE Credit

REALTORS® are required to complete ethics training within designated training cycles. The deadline for the current training cycle is December 31, 2016, and the new "CE" course is one great way to meet this requirement and earn CE credit at the same time. The existing free online course will continue to be available at REALTOR.org until later in 2016, at which time a new and enhanced free non-CE course option will also become available.
