Minutes

July 21, 2018 Grand Hotel, Minot

Present: Shirley Dukart, Jill Beck, Sharon Lunski, Mike Swartz, Kevin Fisher, Larry Louser and Ron Volk. Tate Cymbaluk was absent with prior notice but did call in several times to participate.

- 1. Shirley Dukart called the meeting to order shortly after 9:30 a.m. and welcomed all.
- 2. Jill Beck asked all present to fill out and sign the confidentiality agreements and conflict of interest statements.
- 3. Nancy Willis directed Trustees attention to the binders available to all. Each binder had the following:
 - a. Candidate interview schedule
 - b. NAR's Candidate Interview Guidelines
 - c. NDAR and NAR Advocacy Priorities
 - d. Questions to be asked of candidates for that office
 - e. Candidate bio
 - f. Candidate fundraising information.

If candidate was a state legislator, the binder also contained their voting record in the last legislative session. U.S. Senate and U.S. Congress candidates had the completed Federal Questionnaire required by NAR.

 Trustees reviewed candidate questionnaires and selected Trustees to ask each question. Then the completed Federal questionnaires were reviewed and four questions were prepared for candidates running for U.S. Senate and U.S. Congress.

Candidate interviews were held from 11:00 a.m. to 5:30 p.m. and Trustees entered executive session twice to endorse and make financial commitments. The following candidates were endorsed:

- For U.S. Senate recommendation to NAR to support Rep. Kevin Cramer to the legal limit (\$5,000)
- For Agriculture Commissioner Doug Goehring \$5,000
- For Secretary of State Al Jaeger \$5,000
- For Tax Commissioner Ryan Rauschenberger \$5,000
- For Attorney General Wayne Stenehjem \$5,000
- For PSC Commissioner, 2-Yr Term Brian Kroshus \$2,000
- 5. Trustees also approved a request for state funds in the amount of \$5,000 for Rep. Scott Louser's re-election race for District 5, Minot and did not approve a request from the GFAAR to release 2017 RPAC funds before exhausting 2018 RPAC funds and having candidates designated to receive the contributions and in what amount, which is policy.
- 6. Trustees checked their calendars and chose Tuesday, July 31, 2018 at 1 p.m. as the date to complete candidate interviews. Trustees can choose to meet in Bismarck faceto-face at the Association office or via conference call. Candidates remaining are PSC Commissioner, Randy Christmann and U.S. Congress candidate, Mac Schneider. Staff was asked to contact the candidates and offer them the interview opportunity.

Trustees also agreed to hold a Trustee meeting in combination with the interviews to review and act on February 21, 2018 meeting minutes and any other business needing

to come before the Trustees.

There being no further business, the meeting was adjourned at 6:00 p.m.
