

Many changes have been seen over the years from daily hot sheets to weekly MLS books that were coveted and marked up. Majority of our members don't remember having to go to the local board offices each morning to pick up the new listings from the day prior along with any changes and the weekly books and how anxious members were to get their hands on those. With that being said I guess I am aging myself and how long I have worked for the REALTORS<sup>®</sup>.

Now everything is electronic and changing continuously. Where will we be in a year, five years, ten years or another fifty from now?!!? Only time will tell.

It's also an election year and an electric one it is! Lots of emotion and lots of change. Change is always good but with the re-districting of legislative districts this year there is much to be paying attention to. There are also retirements happening. Below are some of the legislative district changes happening:

- \*Of the 94 House seats there are 67 open seats
- \*Of the 47 Senate seats there are 32 open seats
- \*Of those numbers there are 11 representatives and 7 Senators retiring
- \*11 Incumbents were defeated in the primary election
- \*30 districts have contested races in the General Election and
- \*69 new candidates move to the General Election

So, these numbers equate that there will be at LEAST 32 newly seated legislators (23%) in 2023. We have a few months until early voting or the election happens so, please start paying attention to your local candidates and state candidates and be an informed voter.







## N.D. real estate license rule changes took effect July 1, 2022

The N.D. Legislative Rules Committee approved the final rules changes, codified in North Dakota Administrative Code (NDAC) Chapter 70. These updated rules took effect on July 1, 2022.

In June, the N.D. Real Estate Commission emailed information on the rule changes to all licensees. Some major changes are highlighted below for information. Always refer to the actual language of the entire rule for accurate interpretation.

### Trust accounts - NDAC 70-02-01-15, and repealed - 70.5 - RETA Committee

### Tracking, transferring earnest money, non-interest bearing

The updated rule clarified that the broker is responsible for tracking all earnest money including money wired by the buyer to either the broker's trust account or to a non-broker third party. Refer to 70-02-01-15, the added language is subsection (f).

### Trust accounts are non-interest bearing, RETA eliminated

- Trust accounts must be non-interest bearing, the Real Estate Trust Account Committee rule (NDAC 70.5) was eliminated and references to RETA are no longer in the rules, to reflect 2021 law changes.
- Updated trust account language
- Language was eliminated referencing definition of "authorized financial institution," kinds of trust account cards, permanently bound record book, and interest tracking in trust account processes.

### Teams – definition, advertising -- 70-02-03-02.1, broker responsibilities for teams -- 70-02-01-21

- <u>Teams defined and teams advertising</u> (70-02-03-02.1) A team is 2 or more licensees who work for the same brokerage under the supervision of the designated broker, who work together on real estate transactions to provide real estate brokerage services, represent themselves to the public as being part of a team, and are designated by a team name. Advertising by a team must comply with all requirements of section 70-02-03-02.1. Teams may not advertise in any manner which suggests a team is an independent real estate brokerage firm.
- Broker responsibilities and supervision of teams (70-02-01-21)
  - The designated broker is responsible for:
    - □ supervising teams and
    - □ shall have a written policy that identifies and describes the team relationships in which its licensees may engage.
    - Designated brokers shall maintain a chronological written record of all teams and team membership, and
    - provide such records to the commission upon request.

### Advertising, including advertising by teams - 70-02-03-02.1

• Trade name. Advertising must be done in the real estate brokerage agency's trade name as licensed with the commission and the trade name must be equal to or greater than, in size and visibility, the name of any salesperson, associate broker, or team on the advertising. Discipline of licensees based on failure to meet this size and visibility requirement will be delayed until January 1, 2023.

### Continuing education (CE) -- 70-02-04

- Annual continuing education required for a licensee to renew as active increased from 9 hours to 12 hours.
- NDREC has waived the additional 3 CE hours for the current CE period only Nov. 16, 2021 through Nov. 15, 2022.
- New salespersons who have completed the 90-hour pre-licensure course are exempt from the CE requirement for their first license renewal.

### Fees - limits increased but no fee increases now

- The limit on fees NDREC can charge for organization licenses (70-02-01-02), pre-licensure course applications (70-02-02-02), and CE course applications (70-02-04-07) was increased.
  - NDREC is not increasing these fees at this time.

### The Election

The election of officers shall take place from Friday, August 12th - Tuesday, September 13th with election results to be announced on Tuesday, September 13<sup>th</sup> at the General Membership Meeting.

#### **ARTICLE VIII. Section 1. Nominations Task Force**

The Task Force shall nominate at least one candidate for each office and position on the Board of Directors, which is filled by election of the membership. Additional candidates, who must be members in good standing, may be placed into nominations by submitting a nominating petition, provided by the Association that contains signatures of at least 50 members in good standing. Such petitions must be received at the Association office no later than 45 days before the election.

Nominations by the Nominating Task Force and by petitions shall be disseminated to the general membership at least 30 days prior to the election. The election is held during the Annual Membership Meeting of the Association.

As the need should arise, the Task Force shall additionally nominate candidates for the position of Director to the National Association of REALTORS®.

#### **ARTICLE VI. Section 1. Annual Membership Meeting**

The Association shall have an Annual Membership Meeting for its Members in the month of September at a time and place as has been designated by the Board of Directors. The meeting will always be held in conjunction with the Annual Convention of the Association. Members, as listed in Article II, Section 1, B, C, and D, and who are considered to be in good standing per Article III, Section 3, are entitled to fully participate and vote on all matters which come before the Annual Membership Meeting without any further restriction as to qualifications.

### Section 1(A). Voting procedures for REALTOR® Members. Voting in Person

REALTOR<sup>®</sup> and REALTOR<sup>®</sup> Associate members who are present at the annual or special membership meeting and who are members in good standing (Article III Section 3) shall be entitled to vote at such meetings.

#### **Absentee Voting**

REALTORS<sup>®</sup> and REALTOR<sup>®</sup> Associates who are members in good standing (Article III, Section 3) and who are not present at the annual or special membership meeting may vote by absentee ballot. Absentee ballots will be published to members by the Association with descriptions of the substance of any proposals at least 30 days prior to a membership meeting.

#### Section 1(B). Absentee Ballots

Absentee ballots must be received by the Association office 10 days prior to the annual membership meeting.

Any REALTOR<sup>®</sup> member who will <u>not</u> be able to attend the General Membership Meeting on September 13, 2022 at 2:15 pm may vote by Absentee Ballot.
