Minutes of March 1, 2022 were reviewed and approved. (MSC)

Committee purpose was reviewed.

Jill Beck reviewed the financial statement and did a reminder on the splits with NAR and the locals and how to determine what is available to locals.

Lisa Feldner discussed the redistricting and a map was shared with the local board jurisdictions outlined as well as the new legislative districts. She also covered legislative races to be watching and gave an update on interim committees and other issues of importance.

Statewide interviews to be held on July 23 on the state fair parade day were discussed and process was reviewed.

RPAC Bylaws and Policies were reviewed. No recommended changes to the bylaws and after discussion on the policies a change was requested. Motion made to update in policies section III. A. RPAC Trustee meetings (including candidate interviews) are open to any member that is a RPAC investor for the current year at the minimum state investment level at the time of the meeting. (MSC)

At this point the RPAC Trustees went into Executive Session with just the Trustees and Jill Beck and Lisa Feldner present.

The process was reviewed and agreed upon that just one person ask the questions of the candidates to be consistent throughout the meeting. Consensus was to have Tate ask the questions.

The races were discussed and staff and Trustees to think about each race and what questions to ask and to let Tate, Jill or Lisa know. They will be sent to the Trustees prior to the interview meeting. At this time we are thinking the meeting could be starting about 10:00 am and going into late afternoon/early evening.
