Meeting was called to order at 10:17 and it was noted that Larry Louser will join meeting after discussion of request for funding from Scott Louser due to conflict of interest. (MSC)

Requests for funding were received for REALTOR members Scott Louser (Minot) and Paul Clarys (Dickinson)

The request for Scott Louser was discussed. The Minot Board of REALTORS® requested \$5,000 from their local funds and also \$5,000 from the state. It was stated he is unopposed and is also a Presidents Circle member and major investor. After discussion it was moved to:

To fund Scott Louser at \$5,000 from state funds. (MF)

To fund Scott Louser at \$3,500 from state funds. (MF)

To fund Scott Louser at \$2,500 from state funds. (MF)

To fund Scott Louser at \$3,000 from state funds with consideration for debt retirement. (MSC)

The request for Paul Clarys was discussed. The Badlands Board of REALTORS requested \$500 out of local funds and \$500 out of state funds. After discussion it was moved to:

After discussing federal race of Representative Armstrong, it was moved to request opportunity race for him. (MSC)
