



North Dakota Association of REALTORS® Claus Lembke Political Involvement Award

Background Information:

Starting in 2002, the Claus Lembke Political Involvement Award recognizes worthy individuals who have significantly advanced the legislative agenda of the North Dakota Association of REALTORS® through political involvement both in the public arena and on REALTORS® political issues.

Eligibility:

All REALTORS® and Association Executives are eligible for nomination. An individual can only receive the award once.

Selection Procedure:

The selection taskforce shall consist of the last five recipients. The longest-standing recipient of the award shall be the Chair. The most recent recipient shall present the next award.

The Board of Directors must approve the award criteria and guidelines.

The award will be presented during legislative years at REALTOR® Advocacy Day (formerly Legislative Impact Day).

- Use this point System:
 - 45% for Local Activities
 - 35% for State Activities
 - 10% for National Activities
 - 10% for RPAC Contributions
- Nominations may be made by any REALTOR® from ND
- Nominee must fill out the application
- Award winner should not be prior year's REALTOR® of the Year (not back-to-back)
