19 specific contents of this in any way to leverage a better price or more acceptable terms with any other  
20 Buyer(s).
- 21 4. The obligations of this Agreement shall survive any expiration, termination, or cancellation of the  
22 PURCHASE AGREEMENT and/or any other agreement executed between Seller(s) and Buyer(s),  
23 whether the offer is accepted or rejected.

25 of the Agreement may be disclosed.
