14 showing of interest within _____ calendar days from the cancellation of the EXCLUSIVE RIGHT TO
15 REPRESENT BUYER AGREEMENT, Buyer(s) may be obligated to pay commissions and/or broker
16 compensation outlined in the EXCLUSIVE RIGHT TO REPRESENT BUYER AGREEMENT, whether or not
17 the Buyer(s) uses the services of the Broker or Broker's Agent(s).

18 Buyer(s) acknowledges they should contact the Broker or Agent(s) at any time if Buyer(s) has questions
19 regarding the original EXCLUSIVE RIGHT TO REPRESENT BUYER AGREEMENT, this Cancellation, or
20 Buyer's obligations.

21 After the cancellation of the EXCLUSIVE RIGHT TO REPRESENT BUYER AGREEMENT, Buyer(s)
22 understands that Buyer(s) does not have to compensate Broker if Buyer(s) signs another valid EXCLUSIVE
23 RIGHT TO REPRESENT BUYER AGREEMENT contract under which Buyer(s) is obligated to pay a
24 compensation to another Broker. Any exceptions shall be listed in Additional Provisions.
