NAR Code of Ethics Tool – Do You Need Code of Ethics This Year?

NAR has launched a new tool that allows members to check their training status, choose their preferred Code of Ethics training format (online or in person), and go directly to the training options available to them. The Code of Ethics training is a triennial requirement – each member must take an approved course every **three** years. *The current triennial cycle is January 1, 2019 to December 31, 2021.*
